**EXPLANATIONS**

**UNINCORPORATED:**

1. School Total is the sum of the Local and State Millage Rates.
2. MSTU Total is the sum of the Parks, Library and Storm Millage Rates.

**CITY:**

1. Millage Code is a combination of the unincorporated tax code (first two digits), the city code (digits three and four) and the special district code (last digit). Zero indicates no special district.
2. Unincor Millage Rate is the total unincorporated millage rate for the corresponding millage code, minus the MSTU total. Polk County properties that reside within city limits do not pay MSTU tax.
