EXPLANATIONS

UNINCORPORATED:

1. **School Total** is the sum of the Local and State Millage Rates.
2. **MSTU Total** is the sum of the Parks, Library and Storm Millage Rates.

CITY:

1. **Millage Code** is a combination of the unincorporated tax code (first two digits), the city code (digits three and four) and the special district code (last digit). Zero indicates no special district.
2. **Unincor Millage Rate** is the total unincorporated millage rate for the corresponding millage code, minus the MSTU total. Polk County properties that reside within city limits do not pay MSTU tax.
