**RE: VALUE ADJUSTMENT BOARD/DELIVERY OF AD VALOREM TAX ROLL
AND NON-AD VALOREM ASSESSMENT ROLLS**

Dear Chairman Dantzler:

It appears that the Value Adjustment Board hearings and decisions of the Special Master for the 2018 tax assessments will not be completed within the timeframe required to extend the tax roll on time.

If this deadline is not met, we will have a late tax roll resulting in tax notices being mailed after November 1, 2018, causing all taxing authorities we represent (including the Board of County Commissioners) from receiving their tax money on time.

I am, therefore, requesting the Board of County Commissioners order the roll to be extended prior to completion to the Value Adjustment Board hearings per Florida Statute 197.323. If any parcels are altered by the Value Adjustment Board, they can be corrected by Certificate of Correction.

Since this requires the majority vote of the Board of County Commissioners, please put on your agenda no later than your October 25, 2018, Board Meeting to consider this request. If you have questions or concerns, please contact me.
